### **FIRST OBJECTIVE**

- 1. The first thing you are told to do is to visit Mr. Charnel's website.
- 2. There should be a business card included that contains the web address.
- 3. Take note that there are 3 different tabs on the website (1 for each of the 3 cases).









### **GAIN ACCESS TO HAUNT HOUSE**

- 1. You need a special promo code to gain access to Haunt House before it opens to the general public.
- 2. You are told that the promo poster will help.
- 3. Take note of the spiders. They are important.





# MATCH UP WHICH ACTORS GO WITH WHICH HAUNT HOUSE ROLES

- 1. The first major task after getting into Haunt House is to take the list of names provided by Mr. Charnel and match them up with the role they play in the haunted house attraction.
- 2. Note: two of the names aren't actors in Haunt House.
- 3. Use the images on Mr. Charnel's website to determine which two names aren't part of the case.
- 4. These two names will be used to unlock one of the Charnel cards.
- 5. The remaining names can be matched up with their roles based on details in the pictures on Charnel's website as well as physical details provided about each person compared with the requirements listed in each job listing.
- 6. Flo from the ticket booth also has some information that should be helpful in matching up actors with the roles they play.









### **FOUR COLUMNS**

- 1. Throughout your investigation, you will need to determine which actor plays which character, what room of Haunt House they occupy, and which of the Nine Circles of Hell (according to Dante's The Divine Comedy) they would occupy.
- 2. Use this to keep track of your findings as it will make things much easier when it comes time to determine certain passwords and unlock codes.







- 1. You need more information about the murder weapon.
- 2. You have a computer.
- 3. Search for the words written on the blade.









### TEXT BASED ON A VISION FROM THE KILLER'S WALLET

- 1. In the journal is a series of five rows of letters that Mr. Charnel received in a vision he obtained after holding the victim's wallet.
- 2. He has also had a separate vision with a second set of five rows of letters.
- 3. Merge the rows together to form a coherent message that helps provide more information about your suspects.









## PAPER WITH NUMBERS FOUND IN VICTIM'S WALLET

- 1. The puzzle piece on this is the key to this puzzle and links it to the Puzzles of Flesh document (typed sheet)
- 2. The numbers correspond to line and word.
- 3. Pull the correct word and obtain a crucial piece of information about the case.









### CODE BENEATH ART/WHERE DID THE KILLER HIDE...

- 1. There is a code in the journal beneath the skeleton painting.
- 2. To decipher it, consult Charnel's website.
- 3. He gives you a hint about where the hiding place for the letter conversion is.
- 4. One letter converts to the other
- 5. Use the answer to unlock the card and gain more information about the case.









### **VIDEO VISION OF ALTERNATE ROUTE**

- 1. You are told that they were testing out an alternate route for Haunt House when Barrett Conrad was murdered.
- 2. Once you know who corresponds to each character, you can follow the video up til the point that the murder occurred.
- 3. The three suspects that aren't featured are eliminated because they weren't present for the alternate route run through.









### THE NINE CIRCLES OF HELL

- 1. You need to determine which of the Nine Circles of Hell each actor corresponds to.
- 2. Much of this information can be gained from the bios about each person when you determine which character they correspond to.
- 3. Read each bio and determine what sin they are linked to based on their history.
- 4. You should have a post-it note that defines each of the Nine Circles and tells you what they are known for/how to interpret them.









#### SAFE

- 1. The code that's engraved into the handle of the murder weapon gives you the combination needed to open the safe.
- 2. Each letter corresponds to the first letter of one of the Nine Circles of Hell.
- 3. If you've been filling out your 4 columns throughout the investigation, you should have all of the suspects matched up with their character, their room number, and their circle at this point which should make obtaining the combination much easier.









#### SUSPECT ELIMINATION

Two suspects are eliminated by

Demi Elliott(Ghoul) - In the unlock about which two suspects are not employees, you are told by Jakob that Demi had a crash on Barrett, so she is not the killer.

The video on the website reveals who the three people who were not there for the run-through are.

Two people are eliminated from the message you get for the paper with the number, and the Puzzle of Flesh story.

In the computer search unlock, Roger refers to the person who bought the murder weapon in a way that will let you eliminate one or more suspects.

The wallet puzzle reveals that one of the suspects is left-handed, and you are told by Flo that the killer is right-handed.









### **READY TO CLOSE THE CASE?**

- 1. You need to have solved all other puzzles before you can do this.
- 2. Who killed Barrett Conrad? See Suspect Elimination page above.
- 3. What person or people were behind it all? Get the safe unlocked and pay attention to what Charnel says.
- 4. What was the name of the evil? You get this answer from the Computer Search Unlock.
