ANALYZING EACH HAND/DETERMINE WHICH BUSINESS THEY ARE CONNECTED TO

1. There is something very specific about each hand that corresponds to one of the businesses on Mr. Charnel's website.
2. There should only be one business that corresponds to each hand.
3. Once you know which business corresponds to each hand, you will be able to unlock each gravestone once you know the order in which each victim was killed.





DETERMINE THE ORDER EACH VICTIM WAS KILLED

1. In Mr. Handy's Guide To Delivering Justice, he gives you a set of rules to determine the order the five victims were killed.
2. Place the in the correct order according to the conditions he has set, and you will know the number of each victim.
3. Once you know this, you can unlock each gravestone based on the location name/business that corresponds to each one.

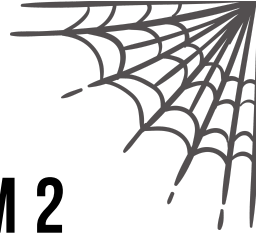




3 ROWS OF LETTERS/VICTIM ONE

1. When you know the location that corresponds to victim one, you get the following information:
2. Nancy isn't your type. Count the pinky as one, the ring finger as two, and so on. Follow the dragonfly.
3. This leads you to the note with the typed font/3 rows of letters.
4. Mr. Handy has already told you that he counts the thumb as a finger.
5. If you count the pinky as one and move across the hand, then the thumb will be five.
6. Following the dragonfly means to pull every 5th letter from the strands of letters and obtain a message.





NOTE WITH MISSPELLED WORDS/VICTIM 2

1. When you know the location that corresponds to victim two you get the following information:
2. "Also, the note I received said to take all the wrong letters and move one along the alphabet."
3. Find all the letters that don't belong in the note and pull them out.
4. Then, take each one and shift forward one along the alphabet.
5. Example: a becomes b, b becomes c, etc.
6. Obtain a message.





NOTE WITH NUMBERS AND LETTERS ABOVE AND BELOW LINES/VICTIM 3

1. When you know the location that corresponds to victim three you get the following information:
2. “Yeah, it said, you would need to pay close attention to things in fives. Things like vowels, oceans, senses, and the W’s (who, what when, where, and why). I thought somebody was messing with me. Part of me still thinks that.”
3. Find the things above the line that are part of anything that comes in a group of five and then take whatever is below the line.
4. You should end up with two words from what you obtain.





CLOCK/VICTIM 4

1. When you know the location that corresponds to victim four you get a series of times.
2. Find the times you are given on the clock and pull the letter that corresponds.
3. You will obtain words from this.





HAND STAMP/VICTIM 5

1. When you know the location that corresponds to victim five you get the following information:
2. “When someone comes and asks about the cop with stitches, tell them that the cipher conversion can be found on the hand stamp.”
3. You will see two letters stamped on the hand.
4. This gives you the conversion for the cipher in the casebook that mentions dancing (this links the cipher to the dance club).
5. E becomes P, F becomes Q, etc.





ONCE YOU KNOW WHO I'VE KILLED... /BACK PAGE OF MR. HANDY'S GUIDE TO...

1. Once you have solved the previous five puzzles, you should be able to fill in all the blanks on the back of Mr. Handy's Guide To Delivering Justice.
2. Pull the letters in the correct order (numerically) and obtain needed information.





DO YOU KNOW WHERE IN VALLEY FALLS I HID THE BODIES?

1. Once you have unlocked the back page of Mr. Handy's Guide To Delivering Justice (number blanks puzzle), you will see a file.
2. To the right of the handprint, you are told to examine three sections of the list of businesses on Mr. Charnel's website.
3. Follow the instructions for each set of businesses.
4. Note the * symbol separates the sets of businesses. It mirrors what is on the website.
5. You should obtain three pieces of information about where to search.
6. Note: this unlock will have 3 password fields that you will use.





WHERE IS THE LAST LOCATION WHERE YOU SHOULD VISIT?

1. After unlocking the previous file (Do You Know Where In Valley Falls I Hid The Bodies?), you should have a string of numbers.
2. In the last group of businesses that you haven't used on Mr. Charnel's website, use these numbers to determine which letter to pull from each line.
3. This will give you a location.





COLUMNS OF LETTERS IN THE JOURNAL

1. Mr. Charnel has a clue about the correct order of these columns.
2. Use the six letters he posted to organize the six columns correctly.
3. He mentions it's written in the stars which is a clue about what you will find when you order the columns correctly.





FRONT COVER OF MR. HANDY'S GUIDE

1. Mr. Handy tells you that you are looking for a phone unlock.
2. This will become more apparent context-wise after reading the previous unlock.
3. He tells you where in the column puzzle to look for the word you need.
4. He also tells you what number to use.
5. At this point, that information should be readily available to you and you can solve the case.
