Eliminating Suspects

*Note: Spoilers Below! Only proceed if you want to know how to eliminate each suspect that isn't the killer!

Suspect Eliminations:

Hilda Van Buren passed away in her sleep on the evening of April 21. The crosses turn at the same time each night to indicate the time of death (9:26 pm). The coroner's report (gained by exploring the mausoleum, solving the button puzzle, and unlocking the What Type of Plant Is The Blue Flower? card) says that Hilda ingested the foxglove 20 minutes prior to death which would mean she drank the poisoned tea at approximately 9:06 pm. Thus, whoever killed her must have had the opportunity to poison her tea right before she drank it.

Gina Sutton: We see that she confirmed the Holmes Film Club on 4/21/2018 at 9:05 pm. This makes it unlikely that she is the killer. Also, the EVP found on the STALK website that says "The greenhouse doesn't breed killers." In her interview, Gina talks about spending a lot of time as a child in the greenhouse with her mother and there is a photograph of the greenhouse in the box with a note from Gina's mother to her.

Karl Benefield: Karl is exonerated by the candle puzzle (found on the STALK website) that says: "The gatekeeper was at his post."

Mallory Middleton: Mallory is eliminated as a suspect by the phone puzzle on the star poster that lists the time of the senior class bonfire as April 21 at 9pm. One of Anna's visions on the STALK website says "Two people in the house will be proven innocent by stars and music." Mallory is one of these people.

Jeffrey McComb: One of Anna's visions on the STALK website mentions "Johnson Road visit was fifteen minutes." The Johnson Road service call occurred right before he went to Indigo House. He was at the Johnson Road address at 8:58 p.m. Staying there fifteen minutes would put him leaving at 9:13 p.m. If Mrs. Van Buren ingested the poison around 9:06 there is no way he could be the killer since he wasn't there at the time.

Enzo Baptiste: The EVP found on the STALK website says "The greenhouse doesn't breed killers." Enzo is in charge of gardening and manages the greenhouse.

Dalton Middleton: Scanning the concert ticket, confirms that Dalton was at a concert which began at 9:00 pm.

Henry Carson: Henry is eliminated by the floor puzzle which rules out Suspect #2.

Violet Middleton: In the music puzzle, Violet receives a message that says "Opera 21 at 830." The Will Street Notes mentions the chef talking on the phone and mentioning that the opera lasts two hours. So we know the opera lasts from 830 to 1030 on the 21st. One of Anna's visions on the STALK website says "Two people in the house will be proven innocent by stars and music." Violet is one of these people.
