

The Cabin Hint File

Each page will contain hints for 1 puzzle.

*Solutions will appear in a separate file.

Archery Puzzle

1. Use the archery score card and the archery target.
2. Determine the color of each score for each counselor.
3. Example: Trish would be Yellow, Red, Yellow since she scored a 10, 8, 10.
4. Eliminate all counselors based on their scores using the color order listed below the target.
5. You will only have one counselor left.
6. This eliminates a suspect.

Bonfire Puzzle:

1. Use the Will Street Memo to determine who is sitting where at the bonfire.
2. Use the skull card to determine which counselors became victims of The Reaper
3. The skull has the numbers 910 see this as 9 and 10 and answer the question who sat in those seats.
4. Here are the first two if you are having trouble. Johnny is sitting at seat 4 and Trish is sitting at seat 1.
5. Once you finish this will eliminate 2 suspects.

Cave Drawing Puzzle:

1. Use the cave drawing and Reaper profile to solve.
2. Examine the code at the bottom of The Reaper profile
3. There are 26 characters on The Reaper profile-each corresponds to a letter of the alphabet.
4. Substitute the correct letters into the cave code.
5. This eliminates a suspect.

Totem Puzzle:

1. Examine the symbols at the top of the Totem puzzle.
2. Examine the handbook to find the same symbols.
3. Use the order that the symbols appear in the handbook to provide the correct order for the columns of letters.
4. Rewrite the columns according to the symbol above them, using the handbook to determine order.
5. Read from left to right, top to bottom.
6. This message should start with "wwwdot"

Dock/Grid Puzzle:

For boxes purchased during or after 2020.

1. Find the postcard with the boating/fishing symbols on it and the grid sheet with a boat dock in the background.
2. The card tells you the order. Find each square on the grid that corresponds to the appropriate symbol. Then, find that same square on the dock side of the page. Follow the up, down, left, and right directions for each symbol and notate the words that are found in each square.
3. Note: Do not try to read through the paper. That is not how this puzzle is worked.
4. Example: The paddle symbol is in the first row, fourth column. This matches with the word Counselor since it is in the first row, fourth column on its side of the paper. Next move down, left, left, so the message you get starts with "Counselor in cabin six..."
5. This eliminates a suspect.

For boxes purchased prior to 2020

1. Find the postcard with the boating/fishing symbols on it and the grid sheet with a boat dock in the background.
2. Visit the Will Street Detective Agency Facebook Page mentioned on the business card.
3. The card tells you the order. Find each square on the grid that corresponds to the appropriate symbol. Then, find that same square on the dock page. Follow the up, down, left, and right directions for each symbol and notate the words that are found in each one.
4. Example: The paddle symbol starts on the word Counselor then moves down, left, left, so the message you get starts with "Counselor in cabin six..."
5. This eliminates a suspect.

Sheriff's Department Evidence Puzzle:

*Totem Puzzle must be solved first

1. Go to the place discovered from the Totem Puzzle.
2. Go to the very bottom of the page and follow the instructions about sending the email.
3. Examine the bottom half of the graphic you are sent for a hint about each line of the Evidence Puzzle.
4. Each line references common things that have a specific order. The hints contained in the graphic tell you line by line where those items come from.
5. Fill in the one that is missing for each line and use the first letter of the word.
6. Here is what you need to be thinking about in order to solve:

Roman Numerals
Books of the Bible
Months in a year
Planet Names
Places you score in a race
The Great Lakes Names
Music Notes
Colors of the Rainbow

Writing on the Cabin Wall Puzzle:

*You need to complete Totem puzzle prior to solving this

1. You will need the Camp Grand Echo Button and the graphic you obtained in the search for the solution to the Sheriff's Department Evidence puzzle
2. Use the button and the code on the emailed graphic to substitute the correct letters on the wall writing.
3. *Note: Any letters that are changed should only be changed once.
4. The message should start with "Hey Rick remember..."

Cabin graphic (-10, QR code)

1. Take each letter in the code and move backward in the alphabet 10 spaces.
2. Substitute that letter for the one shown.
3. Message should start with "List all of..."
4. Use the Camp Blood Mortycian Productions poster for the order described
